I am writing to acknowledge receipt of your email dated 20th February 2021 (received into our office 21st February requesting information under the Freedom of Information Act (2000) regarding diagnosis.

Under section 8(1) of the FOI Act, requestors are required to provide a full name in order to make a request valid. The Information Commissioner states that a "title and/or first name with surname satisfies the requirement for provision of a real name, as does the use by a female applicant of her maiden name". Therefore, in order to proceed with your request can you please supply us with a valid name?

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 The total number of patients who have been recorded with a first diagnosis or seen for the first time in relation to symptoms of myocarditis, pericarditis, heart attacks or any







other heart related conditions in each year between the range of years starting with the 1st January 2012 up to the 31st December 2021.

1. The methodology considers when a patient was first identified with a condition within an inpatient (admitted) setting (where diagnosis codes are identified). Patients that may have conditions identified in other Trusts or in other settings are not included.

- 2. The source data is the Trusts datawarehouse, but data exists only from April 2011. This means, for example, that if a patient was first diagnosed in 2009 and re-presented in 2012, then this would be included within the 2012 numbers. It's likely therefore that within the early period, say 2012-2014 this is likely to be overstated.
- Q2 The total number of patients who have been recorded with a first diagnosis or seen for the first time in relation to symptoms of immune deficiency diseases such as HIV and AIDS in each year between the range of years starting with the 1st January 2012 up to the 31st December 2021.

(iv) Data that does not include on-going or existing patients with a previous history or treatment of such conditions; and

(v) Can you identify in respect of each year and patients, the number that have received a single, double or triple Covid vaccinations since they were introduced?

A4 UHNM in not a vaccination hub, therefore this information is not held, local GP practices may hold this.
