I am writing in response to your email dated 22nd March 2020 (received into our office 23rd March) requesting information under the Freedom of Information Act (2000) regarding Zero Hours Contracts

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in question 4 is not held centrally, but may be recorded in individual staff records. In order to confirm whether this information is held we would therefore have to individually access all individual staff records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual staff records and then extracting relevant information would take longer than the 18 hours allowed for.

In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive* burden on the authority

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just the questions that we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

I write to request information about University Hospital of North Midlands NHS Trust's policy and practice on zero hour's contracts and other associated statistics under the Freedom of Information Act 2000.

What is your policy on zero hour's contracts?

A1 Those registering to work on the Trust Bank are classed as workers. They complete a registration document which sets out the terms of their registration. Once registered on the Bank, they may be asked from time to time if they wish to carry out specific time limited Assignments at the Trust and they can choose whether or not to accept or decline the Assignments offered. There is no obligation on the Trust to offer work and no obligation on the worker to accept it. The registration document is not an employment contract and does not confer any employment rights on the worker.







- Q2 How many workers are currently employed by University Hospital of North Midlands NHS Trust on zero hours contracts? What is the breakdown of this figure according to the following?
 - (a) Occupation
 - (b) Sex
 - (c) Race
 - (d) Age
- A2 University Hospital of North Midlands NHS Trust employs 1557 workers as bank only staff on zero hours contracts. However, please not that many of our Medical staff hold posts allocated as "Bank only" and also hold substantive posts. These are included in the numbers below.
