## Dear

I am writing to acknowledge receipt of your emails dated 30<sup>th</sup> September and 11<sup>th</sup> November 2022 requesting information under the Freedom of Information Act (2000) regarding bronchoscopes

On 3<sup>rd</sup> October 2022 we contacted you via email asunder section 8(1) of the FOI Act; requestors are required to provide a full name in order to make a request valid. The Information Commissioner states that a "title and/or first name with surname satisfies the requirement for provision of a real name, as does the use by a female applicant of her maiden name". Therefore, in order to proceed with your request can you please supply us with a valid name? Once we have received this we will continue to process your request. If we do not hear from you within the next two months we will assume you no longer require this information and will close your request.

In addition to the above, we require clarification on the specific time period please can you advise from what date require the information to begin and end at.

On the same day you replied via email with your full name and clarified the timeframe as: 'It would be for the last 12-months, so say 1st October 2021 to 1st October 2022.'

On 11<sup>th</sup> November we contacted you via email as UHNM has received several requests that are asking for similar information that we believe are from the same person/company, therefore we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests on rigid bronchoscope- previous ref 362-2223 and rigid bronchoscope

Your new reference number is 453-2223 for both requests

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
