I am writing in response to your email dated 4th May 2020 requesting information under the Freedom of Information Act (2000) regarding acute beds

On our acknowledgment we added the following statement:

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

On 5th May 2020 we contacted you via email as we required clarification on the following:

• When you ask how many patients were admitted do you mean unique patients admitted once or total admissions?

• What are you defining as an acute bed?

• What do you mean by "Please discount any community patients?"

On the same day you replied via email with the following:

"When you ask how many patients were admitted do you mean unique patients admitted once or total admissions? Total admissions to your Trust in the year of 2019.

What are you defining as an Acute bed? Acute beds where a patient has received treatment as an inpatient (disregarding COVID-19 patients and any community patient services)

What do you mean by "Please discount any community patients" - this more so refers to community MH Trusts and other community services. "







As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Please take this as a request as a Freedom of Information Request. If you have more than one site within your Trust please provide the information as a total for the whole Trust and not on a site by site basis.
 - 1. In the year of 2019 how many patients were admitted into your Trust into an acute bed? Please discount any community patients
- A1 For the period (calendar year 2019) 228,125 patients were admitted
- Q2 Not including any Covid-19 escalation beds, how many acute beds does your Trust have?
- A2 The following information is taken from the daily sitrep return which we submit to NHS England: as at 01/06/2020 across both sites (Royal Stoke and County) we have 1347 beds
- Q3 In 2019, how many deceased patients were managed within your mortuary services throughout your Trust?
- A3 3835
- Q4 Please provide the order codes of the 3 most commonly used/order body bags or concealment bags within your Trust in 2019 and provide a breakdown of amounts ordered for these 3 codes. Please include both direct orders and/or those through any procurement frameworks
- A4 Please see below:
 - Standard body bags = NHS supplies (code VMS015 Total 53)
 - Bariatric body bags = NHS supplies (Code VMS021 Total 13)
 - Envelope concealment bags = Barber Medical (MVFA76 Total 312 (12 x 26 rolls))
- Q5 When ordering mortuary products, do you purchase alongside any other Trusts in a formal or informal purchasing agreement? If so, please name those Trusts.
- A5 UHNM does not purchase for or with any other Trust
- Q6 Do you have hoisting facilities in any of the mortuaries in your Trust?
- A6 Yes
- Q7 How many fridges do you have all of your mortuaries within your Trust?
