I am writing to acknowledge receipt of your email dated 27<sup>th</sup> September 2021 requesting information under the Freedom of Information Act (2000) regarding Patient Feeding and Retail Catering. (Former Foi reference 342-2122)

On 28<sup>th</sup> September 2021 we contacted you via email as we required the following clarification: Retail Catering Services / Patient feeding services are you referring to the CEO etc for these services or the entire Trust?

Q9 &14, what time frame are you referring to?

On 10<sup>th</sup> February 2022 you replied via email; 'With regard to Q9 & 14 this would relate to a normal 12 month period. Ideally it would be pre covid so 2019 figures would probably be best.'

We advised you via email:

The FOI Act (section 45) we are required to keep open requests that have been paused for two months, this we advised you of when we contacted you for the clarification. Two months had passed so your request was closed.

Therefore this is a new request and your reference number is 575-2122

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Services are provided to the RSUH site as part of the PFI agreement which commenced in June 2007 and will last for over 30 years.

County – In house Service; would not wish to outsource; no contract expiry, Annual Turnover 2020/21 £737K

Royal Stoke – Sodexo provide catering services for patients on site as part of an IFM. Other services provided are cleaning, portering, security, distribution, pest control, helpdesk and Hard FM services to the PFI.

As the provision for patient feeding is through an IFM contract, the information is not held at the Trust.

The staff are employed by the Trust's PFI partner, services are provided to the RSUH site as part of the PFI agreement which commenced in June 2007 and will last for over 30 years.

- 15. How many beds are there in the hospital? If there is more than one hospital in the Trust, please can you breakdown the number of beds per hospital building?
- 16. How many staff work in each hospital?
- 17. Do you use a framework for catering? If so, which framework do you use?

I would be very grateful if you would provide the details which gives us more information about how the hospital operates.
