I am writing to acknowledge receipt of your email dated 21st April 2022 requesting information under the Freedom of Information Act (2000) regarding Cataract Surgery.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeayour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

On 28<sup>th</sup> April 2022 we contacted you via email as we required on Questions 5 & 6 what is meant by sub-contractors – we require a more specific definition of who this would include, such as SHS, Agency etc.

On 4<sup>th</sup> May 2022 you replied via email with:

'By sub-contractors I mean, a provider or providers who have delivered this service on your behalf through a sub-contract arrangement. This could be through insourcing or outsourcing'

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
