I am writing to acknowledge receipt of your email dated 28th January 2022 requesting information under the Freedom of Information Act (2000) regarding Roles and Banding.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 How many Trust Executives do you have within the Trust?

Q3 Which is the highest-earning role within the Trust?

A3 I can confirm that the Trust holds information regarding Trust Executives, but feel this information is exempt under section 21: *information reasonably accessible by other means*. This is because the information is available via the Trust's public website at the following link: <u>https://www.uhnm.nhs.uk/media/5541/2020-21-annual-report-and-accounts.pdf</u>

However: We are unable to provide the *detailed* information you require in the requested format as to release this data could lead to the identification of the person involved due to the low number involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*.

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.
