I am writing to acknowledge receipt of your email dated 28th November 2021(received into our office 29th November) requesting information under the Freedom of Information Act (2000) regarding Outsourcing of Radiology.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

A4 Medica is the only supplier that UHNM use for outsourcing Radiology reporting which covers both Royal Stoke and County Hospitals.

All outsourcing is required to go through appropriate procurement frameworks. All appropriate paperwork and checks are undertaken with various sign off required in line with Trust Standing Financial Instruction (SFIs).
