## Dear

I am writing to acknowledge receipt of your email dated 15<sup>th</sup> October 2021 requesting information under the Freedom of Information Act (2000) regarding dravet syndrome.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

I am writing to you under the Freedom of Information Act 2000 to request the following information from neurology or psychology departments treating patients with Dravet syndrome, for the purpose of researching the services provided for patients with this condition.

## Please detail:

- What services are provided by your hospital for patients with Dravet syndrome?
  - Treatment initiation
  - Titration of dose (consider both starting and maintenance treatment)
  - Monitoring (incl. echocardiographies, liver function tests, etc.)
  - Review of clinical presentations (frequency, duration)
  - On-going prescription of treatments
  - Completing the Blueteg forms
  - Other ....

If services are not provided at your hospital

- Where are patients referred to?
- What services do they receive at the other location (see above list for examples)?

We do not require any information that includes identifiable patient information or costs/commercial arrangements.

- Children with suspected Dravet Syndrome have access to 2 consultants with special expertise in Epilepsy. They have access to genetic testing as soon as the diagnosis is suspected
- 2. Treated with the standard regimen Sodium Valproate+Stiripentol+Clobazam
- 3. Support from Paediatric Epilepsy Nurse
- 4. Access to neuro-developmental team for monitoring their development
- 5. Shared care with Tertiary centre and Outreach Paediatric Neurology Clinics done by visiting Consultant Paediatric Neurologist
- 6. Access to Ketogenic diet and CBD Oil (Epidiolex) through tertiary centre
- 7. Regular Monitoring of LFT locally if on CBD Oil or Echocardiogram if starting on a trial of Fenfluramine.
- 8. Access to participate in national studies on Dravet Syndrome
