I am writing to acknowledge receipt of your email dated 2nd December 2021 requesting information under the Freedom of Information Act (2000) regarding digital sepsis alerts.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 We are interested in which alerting algorithms are in use in different NHS Trusts.

As part of this we would like information on digital sepsis alerts in your Trust.

Could you provide the following information?

- a) Does your Trust use an electronic health/patient record? YES/NO
- A1 We have digital observations in vitals, which also covers sepsis, nutritional assessment, Indwelling devices Fluid management.

NB vitals is only used in inpatient ward areas excluding Maternity

- Q2 If YES
 - b) Who is the provider of the electronic health/patient record? eg EPIC and Cerner

If you use more than one system in the hospital could you provide details of the system used for adult inpatients and adult emergency departments?

- c) When was the electronic health/patient record introduced?
- d) Does your Trust use a digital sepsis alert [1]? YES/NO

 - b) Vitals is a system C product
 - c) Introduced in 2017/2018 for observations followed by other modules 2019 including sepsis
 - d) Sepsis assessment, alerts are seen in ward adult inpatient areas excluding maternity

The module calculates a patient's qSOFA score [3] from standard CareFlow Vitals observations [1] taken in the CareFlow Vitals app.

Each of the following results scores one qSOFA point:

- Low blood pressure (SBP≤100 mmHg)
- High respiratory rate (222 breaths per min)
 AVPU: V, P or U and alert/confused OR GCS (ED only): < 15

Sepsis risk assessment [7] is triggered if:

- The qSOFA score is equal to or greater than 2 [4]
- The patient's EWS is equal to or greater than 5 [4]
- An individual observation contributes 3 or more to the EWS [4]
- AVPU = Alert/confused [4]
