I am writing in response to your email dated 7<sup>th</sup> May 2021 requesting information under the Freedom of Information Act (2000) regarding data update.

You stated:

'The response we received on the 08th of Mar was requested on 7th Dec 2020 (Data requested period is from September 2020 – December 2020).

The recent request which was sent on 30th Mar (Data requested period is from December 2020-March 2021), we are hoping to get a recent data. Please let us know if you could provide us with 2021 data.'

On 12<sup>th</sup> May 2021 we contacted you via email with the following: Please can you confirm what set of questions you require UHNM to answer as you send in multiple FOI requests as we need to be certain that we are responding to the correct set?

On 14th May 21021 we contacted you again by email as we still hadn't had confirmation from you as to which set of questions you required answering.

On 24<sup>th</sup> May 2021 you replied via email with a new set of questions (below)

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in question 2 is not held centrally, but may be recorded in health records. In order to confirm whether this information is held we would therefore







have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority* 

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just question 1 we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

## Q1 How many patients were treated in last 4 months by the Dermatology department with each of the following:

- Abrocitinib
- Acitretin
- Alitretinoin
- Azathioprine
- Baricitinib
- Ciclosporin
- Dupilumab
- Methotrexate
- Mycophenolate mefetil
- Pimecrolimus
- Tacrolimus ointment
- Upadacitinib
- A1 We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*. However as the Trust is committed to openness and transparency we can band the numbers as being <5

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed. See below:
