I am writing to acknowledge receipt of your email dated 20<sup>th</sup> October 2021 requesting information under the Freedom of Information Act (2000) regarding Breast Cancer

## Note: we have received this identical request from you twice, but will be responding once

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am interested in understanding how breast cancer is treated by your Trust, specifically around the usage of systemic anti-cancer therapies. Could you please help by providing the patient numbers that I have requested below?

How many patients have been treated for breast cancer (any stage) in the past 3 months with the systemic anti-cancer therapies listed below?

- Aromatase Inhibitor (e.g. anastrozole, exemestane, letrozole) as a single agent
- Abemaciclib + Aromatase Inhibitor (e.g. anastrozole, exemestane, letrozole)
- Abemaciclib + Fulvestrant
- Anthracycline (e.g. doxorubicin or epirubicin) as a single agent
- Atezolizumab +Nab-paclitaxel/Paclitaxel
- Capecitabine as a single agent

- A1 We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information.* However as the Trust is committed to openness and transparency we can band the numbers as being <5

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

- Q2 In the past 3 months, how many early/locally advanced (Stages I to IIIc) breast cancer patients were treated with an Aromatase Inhibitor (anastrozole, exemestane, Letrozole) as a single agent?
- A2 Sixteen (16) \*\*Please note oral medications may also be supplied in primary care. These numbers only include drugs supplied within the Trust\*\*
