I am writing to acknowledge receipt of your email dated 5th January 2022 requesting information under the Freedom of Information Act (2000) regarding delayed pay data.

On 6th January 2022 we contacted you via email as we required clarification on Q1 are you looking for information on late payments due to our error or the staff providing incorrect pay details?

On the same day you replied with: 'Please provide information on late payments due to error on the part of the Trust.'

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Please provide data on the number of NHS staff you employ that have had their monthly pay delayed in each of the last 12 months.

A1 Our monthly payroll has never been late /delayed and has never been a reason for staff getting paid late. However: the only month pay delays are when starter forms are not completed on time and we have to do a separate payment.
