## Dear

I am writing in response to your email dated 19<sup>th</sup> September 2019 regarding information we released to you under the Freedom of Information Act (2000) regarding people with a dementia diagnosis have been detained under the Mental Health Act 1983.

You emailed the following query:

"Thank you, but it's my understanding that a person with dementia can be sectioned by any health professional, not only if they are in a mental health hospital. Please can you check if this is correct"

## Our response:

To clarify the query above we confirm that under the mental capacity act we could hold patients for as long as it was needed until we get a formal assessment under the mental health act or do a DOLs (deprivation of liberty safeguard) referral and in the emergency departments (ED) we could treat patients under the mental capacity act for their whole admission to ED if we assessed them as having no capacity.

Any healthcare professional can use the mental capacity act.

In terms of the Mental Health Act only registered mental health nurses can use section 5(4), doctors section 5(2) and for a full section a mental health assessment team would do this.

In order to obtain any figures on patients held under the Mental Capacity Act we would have to check all patient records which would invoke section 12 exemption: For details please see below.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in your questions is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all individual health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual health records and then extracting relevant information would take longer than the 18 hours allowed for.

In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority







As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Please can you tell me over the last five financial years how many people with a dementia diagnosis have been detained under the Mental Health Act 1983 under section 2 or section 3 of the Act? Please specify whether section 2 or section 3 was used.

- Q3 Please can you also tell me how many people with a dementia diagnosis who were detained under the Mental Health Act have subsequently been turned down for aftercare by a care home, and if more than one care home has turned down after-care please can you state how many homes have done so.
- A3 As answer 1
