I am writing to acknowledge receipt of your email dated 22nd June 2021 (received into our office 23rd June) requesting information under the Freedom of Information Act (2000) regarding Stonewall.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- A2 We received the following information from the regional Stonewall contact link after an enquiry from our Workforce Equality lead:

You rank is 325 out of 503 Your score is 51.5 out of 200.

You were above average in the health sector and all entrants in the employee network section. You were very close to the all entrant's averages in the employee lifecycle and allies and role models sections.

Senior leaders, procurement and service users are the areas you could most develop in.'
