I am writing to acknowledge receipt of your email dated 7th October 2022 requesting information under the Freedom of Information Act (2000) regarding EBME devices.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

# Definitions

**Medical Device** 

A medical device is any device intended to be used for medical purposes. For the purposes of this query, examples such as Anaesthetic machine, patient monitor, Infusion device, ECG Machine etc.

### EBME

Electro-Biomedical Engineering, also referred to as Clinical Engineering, Medical Engineering, Biomedical Engineering, MEMS, etc.

## PPM

Planned Preventative Maintenance, ie annual service.

Fully Comprehensive

Maintenance contract covering cost of Planned Maintenance and cost of repair parts and labour of equipment

### Ad-hoc support

Subcontracted work to engineering company on an informal basis.

## KPI

Key Performance Indicator to measure the performance of a contract or department.
