I am writing in response to your email dated 10th February 2021 requesting information under the Freedom of Information Act (2000) regarding still births.

On 11th February 2021 we contacted you via email as we required clarification your specific definition as to physical injuries for neonates and maternal.

You replied via email with:

- "• By physical injuries for mothers, I meant injury to include perineal tears.
- In neonates, I meant injury to include broken bones and shoulder dystocia".

We responded via email with:

Unfortunately that doesn't answer our request for clarification;

Please can you clarify further?

What do you mean by perineal tears as they are a known complication of childbirth, are you specifically referring to 3rd/4th degree tears?

Also shoulder dystocia with injury as most dystocia's have none, therefore please be more specific as to what you mean by "injury"

You replied via email with:

"Of course, I can clarify further. Yes, I refer to 3rd/4th degree tears And with baby injuries, you can just include broken bones/limbs during birth"

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in questions 2 and 3 is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just the questions that we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.







As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Please can I have the following information?
 - 1a) How many STILLBIRTHS and NEONATAL DEATHS (death aged 0-28 days) have been recorded by your trust in EACH of the last 5 years (including, 2016, 2017, 2018, 2019 and 2020, please can I have the information split by year)?
 - b) How many of these deaths were formally investigated as a serious incident?
 - c) How many of these deaths have been found to be *potentially avoidable by* either internal or external investigations, including inquests?
- A1 We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*. However as the Trust is committed to openness and transparency we can band the numbers as being <5

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

- 3a) How many MATERNAL DEATHS and MATERNAL INJURIES during or after birth, have been recorded by your trust, in each year over the last 5 years? (including, 2016, 2017, 2018, 2019 and 2020, please can I have the information split by year where possible)?
 - b) How many of these were investigated as serious incidents?
 - c) How many of these might have been possibly avoidable?

Question 3: Maternal deaths (and See answer 1)

Number and how many of these were investigated as serious incidents and how many of these might have been possibly avoidable?

2020 = <5 (<5 serious incident reported but no breaches of care that would have contributed to the outcome (aortic dissection); <5 epilepsy and <5 meningitis not avoidable

2019 = <5 (No SIs – <5 delivered at another organisation passed away in another speciality at UHNM and <5 suicide

2018 =<5 (No SIs – <5 Cancer related and <5 suicide)







2017 = <5 (No SIs drug related overdose) 2016 = 0
