I am writing in response to your email dated 5<sup>th</sup> November 2019 requesting information under the Freedom of Information Act (2000) regarding Dental Nurses'.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the freedom of information act we are asking all departments if they could give us information on the following things:


Does your Maxillofacial Department have an Orthodontic Department?

- A1 Yes
- Q2 What is your management structure for the department, sisters, RGN's, Senior Dental Nurses', and Dental Nurses'?

## Q3 Do you work alongside ENT departments and Plastics departments?

A3 At the Royal Stoke University Hospital, some of the Oral Maxillofacial Consultants have joint Oncology clinics with the ENT Consultants and we share the same Clinical Nurse Specialists for Head and Neck Cancers. Our Maxillofacial Consultants will also link with their ENT/Plastics colleagues regarding individual patients and provide joint operations in theatres.

## Q4 What is your pay scale for Dental Nurses' in the department, do you have a mixture of band 4, 5 & 6 and what is the progression pathway for these roles?

A4 Skill Mix of Band 4 and 5 dental nurses. We also have Band 2 Nursing Assistants (Dentistry)

Dental Nurses tend to be recruited as a Band 4, until such time as the Band 4 post holder/s gains 2 years' experience within the department and attains 2 of the 3 post registration qualifications outlined in the department's job specifications they are unable to apply for the post of Band 5 Specialised Dental Nurse.

Post registration qualifications must be attained and utilised within the department in order for progression to band 5 to occur. They are able to apply for such posts when a post becomes vacant.

- Orthodontic Therapist, 1
- Restorative Hygienist/Therapist, 1
