I am writing in response to your email dated 12<sup>th</sup> March 2019 requesting information under the Freedom of Information Act (2000) regarding patient falls in and NHS hospital setting.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

## Q1 Background:

An officer at NHS Improvement told me that: "NHS Foundation Trusts should have details on (patient) falls in their organisations."

He also said that Trusts/Boards would also record the severity of the fall.

1. The number of patient falls which have occurred in NHS hospitals within University Hospitals of North Midlands for the years: 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, and 2018.
