I am writing in response to your email dated 18th February 2019 requesting information under the Freedom of Information Act (2000) regarding brain tumour patients.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in question 3 is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for.

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to the remaining questions we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 How many brain tumour patients at Royal Stoke University Hospital are discussed preoperatively in a Multidisciplinary Team meeting between January 2018-December 2018?
- A1 In Financial year 2017/18, 1647 brain tumour patients were discussed, but this includes preand post-operative patients, that are part-way through treatment and those on follow-up. Many patients would have been discussed several times. Please note that information is not held for calendar years.
- Q2 How many brain tumour patients at Royal Stoke University Hospital are operated on by neurosurgeons who spend at least 50% of their time on neuro-oncology activities between January 2018-December 2018?
- A2 In Financial year 2017/18 218 brain tumour patients were operated on by dedicated neurooncology surgeons. Please note that information is not held for calendar years.







- Q3 How many brain tumour patients were referred onto a dedicated out-patient clinic between January 2018-December 2018?
- A3 Section 12 exemption as detailed above. Please note however, all those suitable were referred to a dedicated neuro-oncology clinic. Patients who died or were so ill that palliative care only was appropriate were not referred.
- Q4 Will the neurosurgery department at Royal Stoke University Hospital offer 5-Aminolevulinic Acid (5-ALA) to eligible patients in financial year 2019/20?
- A4 Yes
