A3 Phillips handheld speechmikes (various models) used across the site circa 500 but accurate numbers not available as departments responsible for purchasing own devices outside of a project implementation. The latest bulk purchase of speechmikes was in August 2019. Speech mikes already available. We are phasing out the use of Winscribe dictation in favour of speech recognition and FD links to our current dictation/letter administration system..
