I am writing in response to your email dated 18th February 2020 requesting information under the Freedom of Information Act (2000) regarding the number of deaths in the Trust that were subjected to a case record review.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to make an open government request for all the information to which I am entitled under the Freedom of Information Act 2000.

The figures published quarterly, as required by the National Health Service (Quality Accounts) (Amendment) Regulations 2017, and directed by the National Quality Board National Guidance on Learning from Deaths, on the number of deaths in the Trust that were subjected to a case record review and were judged more likely than not to have been due to problems in care, for each quarter that they have been published.
