I am writing in response to your email dated 5th September 2019 received into our office 6th September) requesting information under the Freedom of Information Act (2000) regarding coding for clinical discharge summary. (previous reference number 323-1920)

On 9th September 2019 we contacted you via email as we required the following clarification: What you mean by which computer programme you use on a clinical discharge summary for HES statistics?

On 8th November you replied by email the following:

"Thanks for responding to my request sent on 5th September. Please do accept my apologies for the delay in sending this email.

I would like to offer some clarification for my submitted FOI request. The requests were sent as part of a national clinical audit run by University of Southampton. Each trust was asked to provide details on how they code several Parkinson-related diseases. Although the ICD-10 codes of each disease are readily available, different trusts interpret and code these rare Parkinson-related diseases differently, leading to a disparity in admission statistics between different trusts. Therefore, it would be very helpful if you could provide the details on how your trust would code these specific diseases precisely on the discharge summaries. Although your trust is specialised in children's care, your response would still be a valuable reference as to how Parkinson-related diseases are coded nationwide.

As for manual coding and computer coding - manual coding would normally be coding used by a reference book and computer coding would be any computer programme used in aiding clinical coding i.e. 3M Medicode".

We replied via email advising you that under the FOI Act (section 45) we are required to keep open requests that have been paused for two months, this we advised you of when we contacted you for the clarification. Two months had passed so your request was closed.

Therefore this is a new request and your reference number is 473-1920

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
