I am writing in response to your email dated 7th November 2019 requesting information under the Freedom of Information Act (2000) regarding laparoscopic sterilisation.

On 11th November 2019 we contacted you as we required the following clarification. Do you want information on patients who've come in specifically to be sterilised or to include those patients who, due to a course of treatment (such as ectopic pregnancies) have been subsequently sterilised?

Also, does the 'sterilisation' need to be for both fallopian tubes? (Bilateral)

You replied the same day with the following:

"Patients who've come specifically to be sterilised through laparoscopic approach and both fallopian tubes unless an absent tube due to congenital abnormality or previous surgery"

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Please can you tell me the number of laparoscopic sterilisation done over the last 3 years?

A1 As per your clarification above: please see below.
