I am writing to acknowledge receipt of your email dated 28th April 2021 requesting information under the Freedom of Information Act (2000) regarding medical locums.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS

On 29<sup>th</sup> April 2021 we contacted you via email as we required the following clarifications:

- 1. Please will can you explain your acronym RMO
- 2. Q3: Please supply the total number of days worked by locum RMO's or junior doctors for 2020-2021 at your Trust.

Can you clarify if you are asking about number of days worked by locum RMO's and locum junior doctors

3. Q4: The hourly rate paid to agencies supplying casual RMO's or junior doctors Can you clarify the term 'casual' please? Do you mean locum?

On the same day you replied via email with:

'In point 3 please would you include days worked by RMO (resident junior doctors) and junior doctors living off- site doing locum shifts.

In point 4, yes indeed I meant locum doctors working both residentially and living off- site.'

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

## Q2 A breakdown of the monetary spend per agency for Medical Locums

- The Trust considers this question to be exempt from disclosure in accordance with section 43(2) of the Freedom of Information Act as to release this information would, or would be likely to, prejudice the commercial interests of the Trust. The Trust has applied the public interest test to this request and feels that the public interest in maintaining the exemption outweighs the public interest in disclosure.
- Q3 Please supply the total number of days worked by locum RMO's or junior doctors for 2020-2021 at your Trust.
- A3 As per your clarification: In point 3 please would you include days worked by RMO (resident junior doctors) and junior doctors living off- site doing locum shifts.

Junior doctors worked shifts on 8968 days. This would equate to 3004 days in total (Hrs/24 hours per day).







## Q4 The hourly rate paid to agencies supplying casual RMO's or junior doctors

As per your clarification: In point 4, yes indeed I meant locum doctors working both residentially and living off- site.

Hourly Rate varied between the range £53 to £65
