I am writing to acknowledge receipt of your email dated 3rd August 2021 requesting information under the Freedom of Information Act (2000) regarding LGBT+ Pride.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am making this request under the Freedom of Information Act.

Please can you provide details of any events, physical installations or infrastructure, or other ways the Trust has celebrated LGBT+ Pride, during the calendar years 2020, and 2021 to date.
