## Dear

I am writing to acknowledge receipt of your email dated 30th September 2021 requesting information under the Freedom of Information Act (2000) regarding Waste Disposal.

Note: we have received this identical request from you twice, but will be responding once.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to you under the Freedom of Information Act 2000 to request the following information from University Hospitals of North Midlands relating to waste disposal services:

The name of the incumbent clinical and hazardous waste collector/disposer.

- Q5 The price per tonne paid for each category
- A5 As answer 1
