I am writing in response to your email dated 21st October 2019 requesting information under the Freedom of Information Act (2000) regarding new staff members.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I would like to know the number of new staff members recruited by UHNM in each month, over the last four years, broken down into:

- a) UK nationals
- b) non-UK EU nationals
- c) non-EU nationals.

To be clear, I'm asking for four years of figures up to the most recent monthly figure available

- A1 Please see below: Note, The data:
 - Is Permanent and Fixed term employees only.
 - Includes numbers of Junior Doctors on rotation
 - Includes new starters who may have transferred into this Trust under TUPE Regulations

The data does not indicate the source of recruitment (which may have been from within the UK)
