#### Dear

I am writing to acknowledge receipt of your email dated 18th May 2022 requesting information under the Freedom of Information Act (2000) regarding our response on patient re-imbursements.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

#### You emailed:

'Thank you for the response. In regard to question 4, I required actual costs re-imbursed for electricity & water. i.e., if a patient dialysed 3 times a week for 4 hours (including all other costs related this, for example RO rinse maintenance etc), how much electricity & water would be re-imbursed per month?'

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Do you provide financial support to your home haemodialysis (HHD) and automated peritoneal dialysis (APD) patients via a re-imbursement scheme for electricity and water usage?
- A1 HHD patients are reimbursed for electricity. Water is only paid if the patient has a water meter and not claiming benefits. APD patients are not reimbursed for electricity or water.







- Q2 What dialysis machines do you use for HHD and APD?
- A2 See below:
  - HHD Machines Fresenius 5008s
  - APD Machines Baxter and Fresenius
- Q3 How frequently do you reimburse utility costs to your HHD patients and APD patients? i.e., monthly, bi-monthly, quarterly, yearly etc
- A3 HHD patients are mainly reimbursed a number of ways this can be quarterly/monthly or they have their bill paid direct to the energy company. Not applicable for APD patients
- Q4 What are the average costs you reimburse to your HHD patients and APD patients for both electricity and water?
- A4 Payment is based on how many hours and days a patient dialyses

## Amended answer as per your query above:

Calculations as below based on hours and days machine is used, it is not a flat payment for all patients. For the purposes of this request calculations based on the majority of dialysis patients i.e dialyses 4 hours per day over 3 days. Reimbursement is generally quarterly.

# **Electricity:**

4hrs + 1 hr clean x 3 days = 15 hrs per week.

Machine uses 1.95KV x 15hrs = 29.25KV.

This provides a payment of £6.201 per week x 13 weeks = £80.613.

### Water:

Water used per week is 1.8 litres.
Water used per quarter is 21.6 litres (based on 13 weeks)
Cost of water is £1.86 x 21.6 = £40.176

Drainage is also reimbursed: Cost of using the drain is £1.22 x 21.6 = £26.352

Water and Drains £66.528 per 13 weeks.

- Q5 When did the service last review its re-imbursement costs?
- A5 01/01/2022
- Q6 Do you provide any other re-imbursements to your patients dialysing at home?
- A6 No other re-imbursements are provided
