I am writing to acknowledge receipt of your email dated 24th January 2023 requesting information under the Freedom of Information Act (2000) regarding deaths in A&E.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Could you provide me with the number of patients to die in A&E at your Trust, broken down by month from January 2010 to December 2022 please?

A1 We only hold data from April 2014 and the below is for Royal Stoke and County ED departments only.

We have identified a person who died within the AE department by looking where the disposal method = Patient died.
