I am writing in response to your email dated 24th August 2020 requesting information under the Freedom of Information Act (2000) regarding cancer patients

On the same day we contacted you via email as we required a time frame in order to collate the information.

On 8th September 2020 you contacted us via email with the following:

"Apologies for not providing the timescale - monthly or quarterly data for the January 2019-August 2020 period would be greatly appreciated.

Also, as well as providing the total number, a percentage would be useful. For example, "24% of cancer patients were waiting more than 104 days for treatment."

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Please send me:

- 1. The total number of cancer patients receiving treatment within 62 days.
- As per your above clarification and amendment to your request, Please see below a table for the requested time period of the actual total 62 Day Referral to Treatment numbers for UHNM and the total treated over 104 days (this data includes tertiary referrals both in to UHNM and out of UHNM). Please be aware that August data is not yet final and uploaded so we can only provide information up to July 2020.
