I am writing in response to your email dated 9th September 2020 requesting information under the Freedom of Information Act (2000) regarding no fixed abode.

As I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in questions 1-10 is not held centrally, but may be recorded in health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for.

In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just questions 1 and 3 we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the Freedom of Information Act I wish to request the following information.

1. Please provide the total number of A&E attendances by patients of No Fixed Abode for each of the financial years from 2009/10 to 2019/20.

A1 Data only held from September 2018, prior to this there was no formal procedure on recording of no fixed abode patients, therefore prior to this date you would have to manually check each record to try to ascertain if the patient was of no fixed abode (NFA) or not. Section 12 exemption as detailed above)

It does not mean this is the reason for the admission.

We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information.* However as the Trust is committed to openness and transparency we can band the numbers.

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

- A10 The current referral process is electronic, and the number of referrals made is not captured through this system as it is external. Staff will make a referral to the relevant authority based on where they wish to reside so there is not one central pint to obtain this information. Whilst confirmation of a referral may be written in a patients note it would require all notes being reviewed to find this information- Section 12 exemption (*cost of compliance excessive*) as detailed above
- Q11 Does the Trust have formal admission and discharge policies in place to ensure homeless people are identified on admission, and that the discharge of homeless people should be notified to relevant primary health care and homelessness services?
- A11 A policy / guidelines is in development, but the staff on the wards have information on where referrals are to go
- Q12 Please confirm whether your Trust has a Pathway team (GP-led in hospital management of homeless patients).
- A12 We do not have a pathway team in the Trust







Q13 Please confirm whether your Trust has an alternative (non-Pathway model) team dedicated to co-ordinating the care/discharge/further needs outside the hospital of homeless patients. Please give the team name and describe its function
