I am writing to acknowledge receipt of your email dated 26th April 2021 requesting information under the Freedom of Information Act (2000) regarding the companies that have any staff who work at Royal Stoke Hospital.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS

On the same day we contacted you via email as we required a time frame for the information.

You replied via email with the following:

' I mean the companies that currently have staff that work there.

If that's not possible, then the last year and if you can establish if any of the companies in the last year have ceased having staff at the Hospital you can delete them from the information supplied to me'

On 28th April we contacted you again via email as we required the following further clarification; Are after All companies that have staff working for 'them' on site doing casual jobs, or companies that RSUH have employed as sub-contractors to complete work on behalf of UHNM?

On the same day you replied via email with the following:

'Thank you for your reply.

"To continue with your request we require clarification on whether you are after All companies that have staff working for 'them' on site doing casual jobs, or companies that RSUH have employed as sub-contractors to complete work on behalf of UHNM?"







The answer is both, as either types of companies could, and I can therefore confirm indeed do, fall within my request. Regarding any having staff on site doing casual jobs, the assumption can be made that their staff will be on site having had permission from the Trust to be there - therefore we can take it that information about any trespassing or 'unauthorised' people on the Trust's site is not within the request. If there is an issue about both sets of information exceeding the cost limit, please prioritise the sub-contractor information first and provide only that if that can be done within the limit (and reveal that this has been the case).'

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Could you please disclose, preferably by PDF, the names of the companies that have any staff who work at Royal Stoke Hospital?
