I am writing in response to your email dated 13/07/2102 requesting information under the Freedom of Information Act (2000) regarding of vulnerable people with disabilities in emergency settings.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 In the Emergency Department (ED) is there a separate waiting area for vulnerable adults with learning difficulties?
- At UHNM there is no specific designated waiting areas for patients with Learning Disabilities at either Royal Stoke or County hospital emergency departments. But at both sites once the patient has been triaged and a Learning Disability has been identified both departments have access to side rooms or relative rooms which is quieter and away from the main waiting area.
- Q2 Are responsible adults allowed to accompany vulnerable adults with learning difficulties when they are seen by clinical staff in ED?
- A2 Yes- although through COVID this has been assessed on an individual dependent on risk at the time
- Q3 Are carers welcome to provide care if needed?
- A3 Yes
- Q4 Does your Trust have policies in place to assess capacity to consent to investigations and treatment for adults with learning disabilities? If so, could you supply me with a copy of these policies?
- A4 See attached Policy C43- Consent to treatment incorporating Mental Capacity Act policy
- Q5 Do you have policies relating to the administration of treatment/pain relief when an adult with learning disability is unable to consent? If so, please could I request a copy of these policies?







A5 Yes - see attached Policy MM03 - Storage, Prescription, Supply and Administration for medicines. Appendix K refers to Covert Administration in Adults
