I am writing in response to your email dated 2nd February 2021 requesting information under the Freedom of Information Act (2000) regarding Ventilators.

On the same day we contacted you via email as we required a time frame in order to collate the information.

You replied via email with the following: "Apologies, the time frame would be from March 2020 - Feb 2021."

On 8th February 2021 we contacted you via email as we required clarification on Q4, what did you mean?

On 9th February 2021 you replied via email with the following: "yes absolutely, what I mean is that have the CPAP devices been found to be more useful than others, in terms of preventing the need for ventilation of Covid patients?"

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I'm writing to you under the Freedom of Information Act (2000) to request information on the usage of certain types of Ventilator within your Trust, based on the models acquired during the ventilator challenge specifically relating to:

- The Penlon ventilators
- The Breas Ventilators
- The Smiths Medical Ventilators
- The CPAP non-invasive units.

I'd like to know, if possible:

How many of the various invasive models were used within your Trust vs how many were ordered (the Penlon units being the most important with regards to this).

- A1 We do not capture the figure for devices in use
 - 34 x Nippy 4 were ordered
 - Dream station Auto cpap x 1453
 - Airvo 2 X 20
