I am writing to acknowledge receipt of your email dated 3rd May 2022 requesting information under the Freedom of Information Act (2000) regarding tariffs.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

On 11th May 2022 we contacted you via email as we required clarification on what you meant by 'overheads'?

On the same day you replied via email with:

'We would define overheads as the Trusts apportionment of costs that are incurred across the whole Trust, for example rates, use of facilities etc'

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in questions 1 to 6 is not held centrally as we don't identify an apportionment of costs to overheads currently, we would need to investigate all areas of the Trust to identify such costs. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all Trust areas and then extracting relevant information would take longer than the 18 hours allowed for.

In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*







Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just questions 7 and 8 we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 From the Education contract for financial year 21/22, how much as a value of the undergraduate tariff is apportioned to overheads for the Trust?

- A1 We don't top slice/apportion a specific % of Health Education England funding as overheads,. Much of our overheads are embedded in departments/services. We have not calculated the cost of this for 21/22 as part of our day to day work and it would take significant time to do so accurately.- Section 12 exemption as detailed above
- Q2 From the Education contract for financial year 21/22, how much as a value of the postgraduate tariff is apportioned to overheads for the Trust?

- Q4 From the Education contract for financial year 21/22, how much as a percentage of the undergraduate tariff is apportioned to overheads for the Trust?
- A4 Section 12 exemption as detailed above
- Q5 From the Education contract for financial year 21/22, how much as a percentage of the postgraduate tariff is apportioned to overheads for the Trust?
- A5 Section 12 exemption as detailed above
- Q6 From the Education contract for financial year 21/22, how much as a percentage of the non-medical tariff is apportioned to overheads for the Trust?
- A6 Section 12 exemption as detailed above
- Q7 Is any of your estate contracted through a PFI (Private Finance Initiative)?
- A7 Yes







Q8 If yes to question 7, as an estimate to the nearest 10% how much of your estate is funded through a PFI?

A8 36%
